It generally includes opportunity identification, market analysis, feasibility, planning, approvals, financing, design, construction, marketing, handover, and post-development management.

2. Why is feasibility analysis important before starting a development project?

Feasibility analysis helps determine whether a proposed project is commercially, financially, technically, and practically viable. It allows developers and investors to identify potential risks, estimate costs and revenues, test different scenarios, and make informed investment decisions before committing significant resources.

3. What are some of the key regulatory considerations in real estate development?

Regulatory considerations may include land and property documentation, development approvals, building requirements, licensing, developer registration, project licensing, and requirements applicable to specific development models such as off-plan sales and leasing. In Saudi Arabia, these requirements are governed by relevant laws and regulations overseen by the competent authorities.

4. What are the main risks that can affect a real estate development project?

Common risks include inaccurate market assumptions, land and site constraints, cost increases, financing challenges, approval delays, construction delays, contractor performance, changes in demand, sales or leasing performance, and regulatory or compliance issues. Effective risk management requires identifying these risks early and continuously monitoring them throughout the project lifecycle.
