It allows developers and investors to identify potential risks, estimate costs and revenues, test different scenarios, and make informed investment decisions before committing significant resources.

3. What are some of the key regulatory considerations in real estate development?

Regulatory considerations may include land and property documentation, development approvals, building requirements, licensing, developer registration, project licensing, and requirements applicable to specific development models such as off-plan sales and leasing. In Saudi Arabia, these requirements are governed by relevant laws and regulations overseen by the competent authorities.
